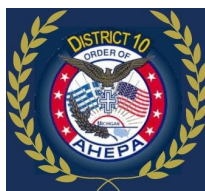
Voting Power

Pursuant to Article 14, Section B of the AHEPA Bylaws, chapters in good standing with a membership exceeding 10 individuals are entitled to elect up to six (6) delegates.

In accordance with Article 12, Section I of the AHEPA Constitution, Past District Governors of any district, who are active and in good standing as members of a chapter within District 10, as well as current elected Lodge officers in good standing, are each entitled to a sovereign vote.

Members of the Board of Directors in good standing, who attain their positions without election, shall not hold an independent sovereign vote. Nevertheless, such members are strongly encouraged to act as designated delegates representing their respective chapters. This measure ensures that their reports, recommendations, and other contributions are communicated effectively and receive due consideration within deliberative processes.

Pursuant to Article 3, Section A of the AHEPA Bylaws and Article 7 of the Constitution: Chapter Members who fail to pay their annual dues to Headquarters, will be deemed inactive and are ineligible to vote, serve as delegates, or otherwise participate. You must pay your dues to Headquarters prior to the convention and Headquarters must receive them.

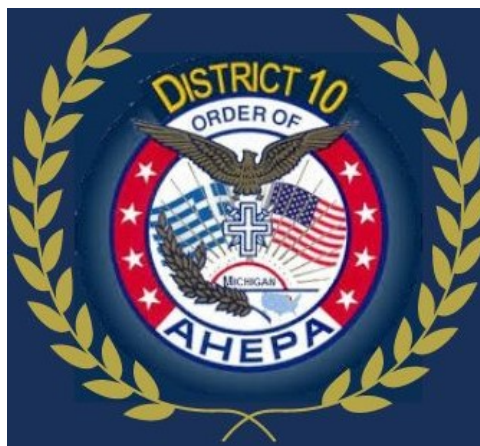
